

1. This approval is limited to those specified in the scope of approval of the approved **Maintenance Organization Exposition (MOE), Issue 01, Revision 07 dated on 15/10/2024**, as amended.
2. This approval requires compliance with the procedures specified in the approved Maintenance Organization Exposition (MOE) and Mozambique Special Conditions Supplement in accordance with current Airworthiness and AMO Regulations (MOZCAR's Part 21/43 and 145 respectively).
3. Parts intended for Mozambique Registered aircraft shall be released by a Certificate of Release to Service in accordance with Mozambique Airworthiness Regulations and AMO Regulations.
4. This approval is valid whilst the approved maintenance organisation remains in compliance with the Mozambique Civil Aviation (AMO) Regulations.
5. Except in so far as the approved Maintenance Organization Exposition otherwise permits, the holder of this Approval shall not furnish reports on work done, or issue certification under the terms of this Approval unless the work reported has been carried out at the following address:

8. Subject to compliance with the foregoing conditions this approval is valid for **Twelve (12)** months up to **13.12.2025** unless surrendered, superseded, suspended or revoked. The holder shall apply for renewal or variation at least sixty (60) days in advance.
